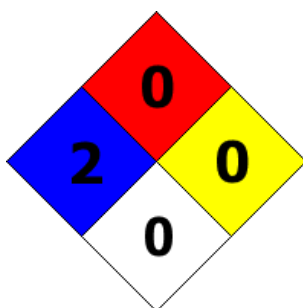

### After swallowing:

## SECTION 5: Firefighting measures

### Extinguishing media

#### Suitable extinguishing agents:
